Maldives straddles the strategically important Sea Lanes of Communication of the Indian Ocean, with over two thirds of the world's maritime oil trade transiting through Maldivian waters.

Understanding the regional security environment and the strategic importance of keeping those SLOCs and choke points open in the Maldivian Waters, the Maldives and Indian Coast Guard started joint Maritime Exercise Dosti in 1991 to

## NCTC OFFICIALS HEADED BY DG BRIG.GEN. MANSOOR AND DEPUTY DG BRIG.GEN. HAMID CONDUCTS A BRIEFING SESSION ON COUNTER TERRORISM FOR DEFENCE MINISTER MARIYA DIDI

28-29 November 2018



Minister of Defence Uza. Mariya Ahmed Didi met the Director General and the senior leadership of NCTC. During the meeting, the Minister was given a comprehensive presentation of the National Counter Terrorism Centre.

The main focus of the presentation was on the national context of Violent Extremism and Terrorism and the strategic response to counter these threats.

The brief highlighted historical perspective of the evolution of Violent Extremism and Terrorism in the Maldives and the strategic responses adopted by the governments. It also highlighted the process of formulation of national policies, strategies, and action plans.

After defining main terminologies, contemporary threat environment (both local and international) was briefed to the Minister. She was also briefed on the process that is involved in radicalization leading to terrorism, the main drivers of violent extremism and also the common narratives that are being used to radicalize the peace loving Maldivian community. The salient findings of the baseline study conducted in March of 2017 was also briefed with special emphasis on the messages and literature that used extensively in the radicalization process.

Minister was also presented some real life examples of Maldivians' involvement in the Foreign Terrorist Fighter phenomenon, their fates and the hardships faced by the family members.

The main narratives being used by extremists in luring youth into the Syrian conflict and the counter narratives that are being used to address these messages were also briefed to the Minister.

The grand National CT/PCVE Architecture as well as the "National Strategy on Preventing and Countering Violent Extremism" and the approaches and the domains in which NCTC has concentrated its effort was also briefed.

The way ahead and the challenges faced by NCTC were also shared. The Minister communicated the Governments' policy on countering Terrorism and Violent Extremism and articulated her policy guidance for future efforts and priority areas for NCTC to focus.

She stated that the main focus of should be on Countering NCTC Terrorism. Deradicalizing and Rehabilitating the radicalized individuals and on protecting the community large from at the influences of extremism.

UN's Resident Coordinator and UNDP's Resident Representative Ms. Shoko Noda and Senior Policy Advisor Mr. Terence D. Jones met the Director General and senior staff of

NCTC as part of his trip to increase the engagement with the new leadership of Maldives.

Mr. Terence D. Jones is a former Resident of United Coordinator Nations who has served since 1969 in some ten duty stations for the UN system over a period of 37 years, and in the 8 country offices and served as the Resident Coordinator in Bhutan, Malawi. and Philippines.

The visit to NCTC is one of a series of visits to senior members of the government of Maldives to identify areas of support that the government require and ways in which UNDP can assist the government in the implementation of its development agenda.

During the visit DG gave a brief introduction of the efforts of NCTC



and the collaborative work that we have successfully conducted with UN bodies, especially UNDP and UNODC.

The Briefing started with a brief introductory video of NCTC followed by answering the queries of the Senior Policy Advisor. UNDP's Resident Representative Ms. Shoko Noda highlighted the excellent working relationship that is established with the National Counter Terrorism

> Centre and congratulated the DG for his efforts and the successes that NCTC has achieved on addressing Terrorism Violent and Extremism through а "whole of government" and of "whole society" She approach. also expressed her gratitude for aligning the NCTC's strategies and approaches with the United Nations' Secretary General's Plan of Action.

Senior Policy Advisor Mr. Terence D. Jones accepted

that due to the geography of Maldives he understood the logistical difficulties that would be associated in reaching the population and he said that UN is fully committed to assist Maldives in its Counter Terrorism and Counter Violent Extremism efforts.

#### **REGIONAL COORDINATOR OF UK'S COUNTER TERRORISM BRANCH CONGRATULATES NCTC ON ITS EFFORTS AND GUARANTEES UK'S CONTINUED SUPPORT**

Director General of National Counter Terrorism Centre Brigadier General Zakariyya Mansoor met Inspector Sean Kelly of the UK's Counter Terrorism International Protect and prepare Coordinator for the South East and East Asia Region. In the meeting, he was accompanied by the Ch. St. Inspector Mohamed Nazim and St. Inspector Samir.

The main aim of the meeting was to discuss avenues of cooperation and collaboration between the UK counter terrorism agencies and the Maldives.

Inspector Sean Kelly expressed UK's eagerness to support Maldives in our PREPARE strand by working closely with the senior leadership of NCTC, MPS, MNDF, including its FIRE SERVICE, COAST GUARD, and the Emergency Medical Services.

He expressed the desire to see how Maldivian agencies have responded to emergencies, to learn best practices that can be adopted. He said that UK has learned extensively from the French response to Terrorist attacks and have modified UK's doctrines and contingency plans accordingly. He further stated that UK could learn from some of the best practices of Maldives and Maldives could learn from that of UK's.

Inspector requested for a scoping trip in the near future with extensive meetings from UK's CT agencies, including fire services and has suggested that a table top exercise would be beneficial for both nations.

BG Mansoor requested for UK's assistance in the Formulation of CT

Strategy and National Action Plans as well as development of Contingency Plans.

DG agreed with the Inspector that the main mission is to save as many lives as possible in an incident and to mitigate damage and disruption to services after an incident happens, so as to come to normalcy as quickly as possible.

He further requested UK's assistance in the prosecution phase and stated with regret that Maldives has faced challenges in prosecuting people who have been suspected of committing acts of Terrorism.

Insp. Kelly invited for a high level delegation of Maldivian CT forces to visit UK in the near future to observe the practices and processes in place in the UK.

# NCTC MEETS THE TEAM OF EXPERTS TRAVELLING FOR COUNTERING FINANCE WORKSHOP IN SINGAPORE

LT. Col. Hussain Ibrahim met the team travelling to Singapore for the workshop titled "Countering the Financing of Terrorism and the Proliferation of Weapons of Mass Destruction" to be held from 4-6 December 2018 for South and South Asian Countries.

This three-day workshop sponsored by UNODC aims to strengthen and develop the capacity of the Law Enforcement and Financial Intelligence Personnel in the financing countering of terrorism and proliferation of WMDs. It also provides the Law Enforcement and Intelligence Officers the necessary tools and practical measures to detect and investigate the financing of terrorism.



The team will be headed by the Director General of National Counter Terrorism Centre and has participants from Maldives Police Service and the Financial Intelligence Unit of Maldives Monetary Authority. These experts will return to the Maldives with increased knowledge and skills and will share challenges, experiences and good practices with counterparts from other nations.

The team was briefed on the Maldivian efforts on Preventing and Countering Violent Extremism and Terrorism.
