


## National Workshop on Rehabilitation and Reintegration Strategies

## A Glimpse at the Role of Educators in a Peaceful and Resilient Islamic Society

he role of educators in fostering a peaceful and cohesive society is pivotal in addressing social and ideological issues. Educators are crucial in promoting positive discourse, increasing knowledge, and cultivating understanding and awareness in communities. By engaging in honest scholarly pursuits, they contribute to the dissemination of accurate information, which can help dispel negative misconceptions and promote the resolution of societal conflicts.

Looking at one of the contentious issues in Islamic theology, Jihad holds a significant place within the framework of Fiqh (Islamic jurisprudence), constituting a multifaceted concept encompassing a range of meanings beyond the commonly misconstrued notion of armed conflict. The responsibility of Islamic educators in elucidating the nuanced understanding of Jihad is crucial to dispel misinterpretations and clarify its true essence in the context of Islamic jurisprudence. It emphasizes that if it is an Islamic country to declare jihad and declare peace, it is in the hands of the government of that country or hakim.

Contrary to widely held misconceptions, Jihad does not advocate nor condone the destruction of places where innocent civilians live. Rather, Jihad in its essence refers to a struggle or exertion in various forms, encompassing spiritual, moral, intellectual, and, in certain contexts, defensive dimensions. The misunderstanding of Jihad primarily stems from its misappropriation by extremist groups like Al-Qaeda and ISIS, and the misinterpretation of historical contexts, leading to a distorted perception of its true meaning and application.

Educators and scholars as custodians of Islamic

knowledge and jurisprudence, undertake the responsibility to expound on the multifaceted nature of Jihad. They emphasize that Jihad, in its legitimate and moral manifestations, encompasses striving for personal betterment, upholding justice, defending against oppression, and promoting societal welfare. This broader understanding of Jihad encapsulates endeavors such as selfdiscipline, charity, education, and peaceful advocacy for societal harmony.

Islamic educators often draw on Quranic verses and Hadiths (sayings and actions of Prophet Muhammad s.a.w) to substantiate the authentic meaning of Jihad. These sources emphasize the principles of compassion, mercy, and the sanctity of human life. They underscore that Jihad when correctly understood and practised, upholds the sanctity of life and prohibits any form of aggression against innocent civilians, women, children, and non-combatants. The modern Geneva Convention reaffirms this under international humanitarian law (the law of armed conflict).

By providing a nuanced and contextualized understanding of jihad, educators help combat extremist ideologies that spread violence and misunderstandings of Islamic teachings. Their role in promoting a comprehensive knowledge of Jihad as a multifaceted concept aligns with Islamic principles of peace, justice, and compassion, fostering a more accurate perception of this intricate aspect of Islamic jurisprudence in the broader context of societal well-being.

Furthermore, educators contribute to societal cohesion by elucidating the concepts of Sunnah and Arab culture in the broader context of Islam. They emphasize that while Islam originated in the Arab world, it transcends cultural boundaries and is adaptable to diverse cultural contexts. It is



crucial to clarify that adherence to Islam does not mandate the adoption of specific cultural practices, such as dress codes like the jubbah and kurta. Instead, Islam advocates modesty and hijab as central principles of attire, emphasizing that cultural variations in clothing do not supersede these fundamental religious guidelines.

In essence, educators play a critical role in fostering understanding, dispelling misconceptions, and promoting harmony in society by imparting accurate knowledge about Islamic principles and guiding individuals toward a more nuanced and inclusive understanding of religion and culture.

Education systems play crucial role in countering extremism & radical narratives. By providing quality education that promotes critical thinking, tolerance & respect for diversity, societies can equip individuals to challenge extremist ideologies. Good education also fosters sense of belonging & inclusion, reducing appeal of fundamentalism.
